2	Matters arising from the previous meeting 20/09/23 Newborough Project – An update was given by ST. It was noted that the PSB, 3rd sector organisations, community leaders and the public will be brought together to work on specific issues which affect the community in Newborough and which are aligned with objectives from the Gwynedd and Anglesey Well-being Plan. A sum of money has been set aside from the Regional Grant Fund to facilitate the work that will be led by Natural Resources Wales. A steering group is in place with officers from NRW, Anglesey County Council and Medrwn Môn which are organising a session to tackle the most frequently raised issues, which is transport and access. Members of the PSB will be invited to attend the session. That in turn causes real concern in terms of its impact on the provision of services that are suitable for our residents for the future. Iaith Cyf has been commissioned to carry out the research.
